

Component	Component Description
Contract	Allegro Contract captures and manages contract information across the enterprise and through contract management processes
Credit	Allegro Credit manages and reports on credit requests, credit ratings, credit review procedures, limits, credit availability, and credit value at risk
Price	Allegro Price captures and manages commodity prices, forward curves, volatilities, and correlations
Currency	Allegro Currency provides multiple currency, currency exchange and trading, and interest rate capabilities
Trade Strategy	Allegro Trade Strategy links physical and financial positions to form strategies for reporting and analysis
Optimization	Allegro Optimization calculates the incremental valuation of all possible dispositions of long and short commodity positions, based on market prices, transportation, storage and processing information
Simulation	Allegro Simulation analyzes potential market changes, including how prices, volatility, interest rates, currency exchange rates, quantities, and weather may impact valuation metrics
Trade Execution	Allegro Trade Execution captures and confirms physical and financial trades for commodities and currency
Position	Allegro Position provides trading and risk management metrics by position, including mark to market, position limits, and profit and loss
Settlement	Allegro Settlement calculates prices, fees, and terms; and creates invoices, statements and accruals for commodity, currency, and services positions
Natural Gas	Allegro Natural Gas manages physical gas scheduling, nomination, capacity utilization, measurement, allocation, and imbalances on natural gas pipelines
Net Valuation	Allegro Net Valuation enables the valuation of inventory along with the ability to complete net forward, net back, and profit margin calculations across commodities including commodity value, transactional, and transportation costs
Hedge	Allegro Hedge defines hedges, performs prospective and retrospective analysis, and creates hedge accounting entries
Property	Allegro Property manages oil and gas producing properties and division orders
Equity Production	Allegro Equity Production manages the marketing of oil and gas production, including volumetric forecasts, nominations, wellhead balancing, measurement, and variance analysis

LNG	Allegro Liquid Natural Gas manages the scheduling and actual measurement of gas-to-liquid and liquid-to-gas processing for LNG operations

Option Analytics	Allegro Option Analytics supports trade capture and valuation of most standard and a variety of exotic option trade types applicable to the energy industry
Pipeline	Allegro Pipeline manages scheduling, shipment, and actual measurement of physical liquid commodities transported by pipeline
Petroleum Blending	Allegro Petroleum Blending manages the scheduling, blending, and actual measurement for blending of liquid petroleum products

NETA Connect	Allegro NETA Connect provides bidirectional web service integration with the NETA market system, including bilateral submission and retrieval of volume, transaction status, forward positions, and periodic reports
ESS Connect	Allegro ESS Connect supports efficient power scheduling communications for electric utilities with delivery obligations in the European power market.
ERP Connect	Allegro ERP Connect provides bidirectional web service integration with Enterprise Resource Planning software
Decision Metrics	Allegro Decision Metrics 8.1 enables companies to create key performance indicators and monitor them in real-time via any web browser or tablet device
Workflow	Allegro Workflow creates procedures to manage documents, data import and export, notifications, and messages
Credit Connect	Allegro Credit Connect provides interface to import credit rating and credit fundamental data
